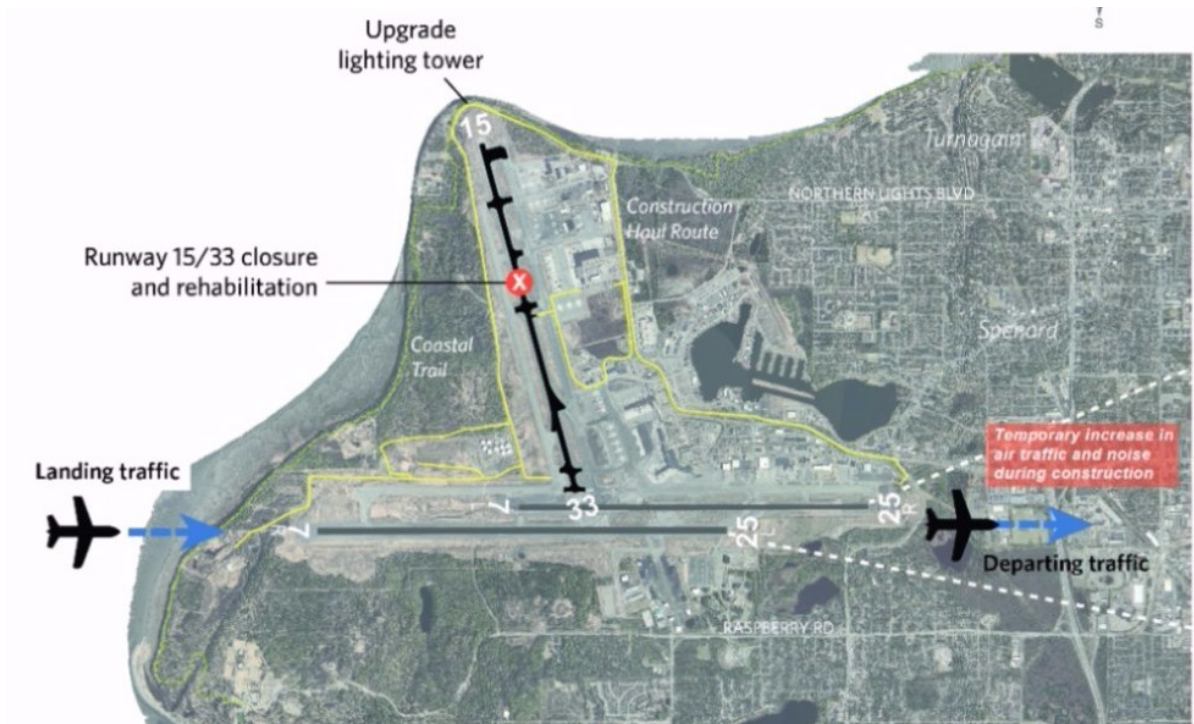

ANC Runway 15/33 Rehabilitation Project

The Alaska Department of Transportation and Public Facilities (DOT&PF) recognizes the need to address the poor pavement conditions of runway 15/33 at the Ted Stevens Anchorage International Airport (ANC), and to maintain the safety and efficiency of airport operations.

The project will rehabilitate RW 15/33 (the north/south runway), widen the runway, and update taxiway geometry to meet FAA standards. In addition, RW 15/33's aging pavement will be repaired. All improvements will occur on airport property. In order to complete this work, the 15/33 runway will need to be closed to operations for one or two construction seasons starting in 2018. Air traffic will be shifted to the east-west runways during construction.
